Talked about traffic issues, lane by the cemetery, sounds like Parks is willing to allow us to use it, wouldn't finish it, hard surface so if it rains won't be able to use it. Need to talk to the road commission about that, may need a deceleration lanes. Complaint from Parks about a lot of smoking throughout the fairgrounds, ask that we make more announcements and more signage to deter them. Parks asked that we don't bring anymore large tires, no more room for them.
