There were 160 hogs registered, 49 sheep tagged, 12 veal and 6 goats on Saturday.

I) PARKS AND RECREATION

R. Usakowski met with Nate and Dennis. Fence at Crater is in, gates need to be put up. Talked to them about paint for horse barns and they will purchase paint and supplies if we have volunteers, need to know when you will do that. Meeting next week and see how many volunteers they can get for that. If they let us know we'll post for volunteers.

They loved the sign idea of putting pole banners on the side of the barns and they will use them throughout the year. Discussion about storage, wasn't open to doing a whole lot on

the north side, but Dennis suggested putting storage containers between the two barns. Potential negative, prices gone up in this park dramatically. Anticipate some increase in our park rent in the future.

J) SPONSORSHIP

Presentation with Comcast about livestreaming ads. Multiple points of data to advertise, list of data points they're looking at and targeted advertisement. Tying demographics into channels on Xfinity. Impressions 177,000, 1,000 spots communicating out, non-skippable ads. \$3750 for them to do that. Some production costs to put together an ad. Camelot Studios cost \$850 for the production. \$4600 total to do that production and advertisement.
