On October 19th will be the 4-H open house, October 27th Furry Scurry which is a dog fun match. L. Warchuck is planning workshops for livestock, Smith Meat Packing, Baker's Culinary Institute, MSU Beef specialists. Livestock is going to pay for those and held November through April.

8) COMMITTEE REPORTS

A) AG EDUCATION

Ag on the Move trailer lacked luster, the one last year was better. L. Warchuck will inquire as to the availability of the trailer used in 2023, who owns it, is it for sale, etc. Genesee County owns the good trailer. L. Warchuck would like a second basketball trailer, but need a box and running gear. Would like to make it shorter for younger children. Petting Farm needs a new coordinator, Sammy is not staying for 2025. This is a paying position, and Nathan Yera may be interested, but needs a committee to do a lot of steps. Need to put together a committee on petting farm.

B) AWARDS

The number of C awards given in the poultry area were a matter of complaints throughout the fair. Many exhibitors expressed they didn't know why they received a C and didn't know that that award did not pay a premium. Discussions regarding whether the judge was given expectations. A motion was made by C. Ruemenapp, supported by A. Thueme to change the C ratings to B's, and B ratings to A's in the poultry project area. Motion carried.

C) AUDIT - No report.

D) CAPITAL IMPROVEMENT

The tiling project will begin soon. Need to discuss restoration. A. Thueme will talk to Steve Thueme to see if he will do it. DTE finished the power to the Crater, which is about a \$25,000 donation. Need to start on the carnival camping area, DTE is working on getting power out there. Our cost will be about \$15,000, panels and disconnects donated.

E) CRATER - No report.

F) ELECTRONIC TICKETING

Eventry can send passes automatically. Volunteer management was more cost. \$3,746 for Saffire. We would replace Saffire with Eventry. Committee meeting on Electronic ticketing 8-29 at 6 p.m. Starlink worked great. Looking for a way to mount it. Alex Vigneron wants to build shelves to put the jacks on. A motion was made by R. Ruemenapp, supported by A. Thueme to purchase 2 Starlinks.

G) FACILITIES

Internet upgrades needed, cost of \$625 with new access point for office and show arena, switch. Items needed to be replaced, new cables, \$250. Alex and Rick talked

H) HANDICAPABLE DAY - No report.

I) LIVESTOCK

Short on poultry pens, large and short pens. Kevin Smith got a quote, moving ahead with that, \$5200 for 75 cages. Currently working on a proposal to replace the show ring, met with livestock superintendents last week, permanent pin together gates, permanent wash rags, hog highway, gates for ends of barns. Sale largest we've had \$477,000. Fair had 5,984 entries, 627 exhibitors. 2023, \$443,000, up 300 entries, 622 exhibitors. 2019 high \$387,000 sale, 7,900 entries, 872 exhibitors.

J) PARKS AND RECREATION

Equipment went out of the park quickly this year. Going to go to the parks meeting on Wednesday. Hopefully bring a fair board report and game plan what we want to do.

K) PERSONNEL

A motion was made by C. Ruemenapp, supported by A. Thueme to approve the superintendent applications of Kara Geib for poultry and Veronica Ruemenapp for Home and Family Development.

L) PUBLICITY

L. Taylor received initial reports from Cumulus, 76,000 geofenced with 15,000 and 16,000 on Friday and Saturday. Ken Sieloff said after his organization paid them, they never received a report from them.

M) SAFETY

Lots of small incidents and car lock outs. Bull rider, couple Facebook posts, mostly directed towards agencies. Spoke to transporting crew, after initial reports, there were no major damages and no major broken bones. 1st Bull rider had a broken collar bone, 4 calls in a short period of time that they were dealing with. All responders followed long standing protocols on how to respond to emergencies, which the public doesn't always understand.

N) SPONSORSHIP

Committee met and updated price list, about out of space at Crater to hang banners and beef arena. New package consists of one banner, small business to come to the fair, carnival and t-shirts.
